

**BYLAW NO. 413-16**  
**SUMMER VILLAGE OF WEST COVE**

**A BYLAW OF THE SUMMER VILLAGE OF WEST COVE, IN THE PROVINCE OF ALBERTA, TO AUTHORIZE THE RATES OF TAXATION TO BE LEVIED AGAINST ASSESSABLE PROPERTY WITHIN THE SUMMER VILLAGE OF WEST COVE FOR THE 2016 TAXATION YEAR.**

**WHEREAS**, the Summer Village of West Cove has prepared and adopted detailed estimates of the municipal revenues and expenditures as required, at the council meeting held on April 28<sup>th</sup>, 2016; and

**WHEREAS**, the estimated municipal operating expenditures and transfers set out in the budget for the Summer Village of West Cove for 2016 total \$ 501,686; and

**WHEREAS**, the estimated municipal revenues and transfers from all sources other than taxation are estimated at \$ 91,490, and the balance of \$ 274,645, is to be raised by general municipal taxation; and

**WHEREAS**, the requisitions are:

Alberta School Foundation Fund	
Residential	\$ 124,244
Non-Residential	\$ 708
Lac Ste. Anne Foundation	\$ 10,599

**WHEREAS**, the Council of the Summer Village of West Cove is required each year to levy on the assessed value of all property, tax rates sufficient to meet the estimated expenditures and the requisitions; and

**WHEREAS**, the Council is authorized to classify assessed property, and to establish different rates of taxation in respect to each class of property, subject to the Municipal Government Act, Chapter M26, RSA 2000; and

**WHEREAS**, the assessed value of all property in the Summer Village of West Cove as shown on the assessment roll is:

# BYLAW NO. 413-16

## SUMMER VILLAGE OF WEST COVE

**NOW THEREFORE**, under the authority of the Municipal Government Act, the Council of the Summer Village of West Cove, in the Province of Alberta, enacts as follows:

1. That the Chief Administrative Officer is hereby authorized to levy the following rates of taxation on the assessed value of all property as shown on the assessment roll of the Summer Village of West Cove:

2. That the minimum amount payable as property tax for general municipal purposes shall be seven hundred dollars (\$770.00).
3. That a penalty of eighteen percent (18%) shall be added on all current (2016) unpaid taxes remaining unpaid after June 30<sup>th</sup>, 2016, and shall be added on July 1<sup>st</sup>, 2016.
4. That a penalty of eighteen percent (18%) shall be added on to all outstanding taxes and related costs that remain unpaid after December 31<sup>st</sup>, 2016, and shall be added on January 1, 2017.

**THAT** this bylaw shall come into force and effect upon the third reading and passing thereof.
