

**BY LAW NO. 435-16**  
**PROVINCE OF ALBERTA**  
**SUMMER VILLAGE OF WEST COVE**

**This is a Bylaw of the Summer Village of West Cove, in the Province of Alberta,  
to be known as the Summer Village of West Cove Fees & Charges Bylaw.**

WHEREAS, in accordance with the Municipal Government Act, R.S.A. 2000, Chapter M26, as amended and the Freedom of Information and Protection of Privacy Act, S.A. 2000, F-25, the Summer Village must make certain information available to the public; and

WHEREAS, in accordance with section 217 of the Municipal Government Act, and section 93 of the Freedom of Information and Protection of Privacy Act, Council may pass a bylaw establishing fees to charge for providing information.

THEREFORE, the Council of the Summer Village of West Cove, in the Province of Alberta, duly assembled, enacts as follows:

1. That this Bylaw may be cited as the "FEES and CHARGES BYLAW".
2. That the Summer Village shall charge fees as established in Schedule A, 'The Fee Schedule', attached hereto.
3. This Bylaw shall come into force and have effect from and after the date of third reading and signing thereof.
4. Bylaw # 425-16 is hereby repealed.

REQUEST FOR ENDORSEMENT	\$50.00
PER LOT AT REQUEST FOR ENDORSEMENT	\$150.00
For subdivision applications made in order to satisfy Section 652(4) of the Municipal Government Act, sometimes referred to as a separation of titles.	
WITH APPLICATION	\$400.00
PER LOT WITH APPLICATION	\$100.00
For subdivision applications made in order to satisfy Section 652(4) of the Municipal Government Act, there will be no fee charged at the request for endorsement.	
For subdivision applications made in order to adjust the boundary of an existing lot:	
WITH APPLICATION	\$400.00
PER LOT WITH APPLICATION	\$100.00
REQUEST FOR ENDORSEMENT	\$50.00
PER LOT AT REQUEST FOR ENDORSEMENT (When new titles are being created)	\$150.00
ENDORSEMENT FEE WHEN THERE IS NO INCREASE IN THE NUMBER OF TITLES BEING CREATED	\$50.00 + \$300.00
